# Why Zero Tolerance?

- Thieves and vandals must first trespass in order to commit offenses
- Trespassers present a danger to employees
- Possibility of injury to trespasser and associated costs
- Train delays
- Derailments



# Evolution

- Began by measuring number of contacts, arrests and undocumented aliens removed
- Measured trends in compromises to intermodal shipments
- Reduction of incidents of injury or fatality to trespassers became primary goal





# Phase One - Preparation

- Identify target area
- Contact law enforcement agencies
- Contact prosecutors
- Contact media representatives



# Phase Two

- Include representatives from other BNSF departments
- Publicize event
- Ensure that proper signage is present
- Thoroughly brief all participants





# Phase Three - Enforcement

- Concentrated effort by team of special agents and local law enforcement officers
- Heavy patrol to include hi-rail and even aerial surveillance where possible
- All trespassers documented and ejected or arrested
- Publicize results
- Positive enforcement



# Phase Four

- Public education
- Employee education
- Long term enforcement
- Feedback to Team members

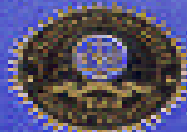
